

America: Built for the White Race

In the last section (4) we learned that the purpose of America was to (1) advance the kingdom of Jesus and (2) for Christians to live in liberty.

Many of the people who came to America had different ideas about how they wanted their colonies to be. Some wanted their church to run the local government - like the Puritans. Others, wanted a Christian government that made people follow moral rules, but not church rules - like the pilgrims. Catholics came to form a colony that allowed more freedom than the Catholic church in the old world. There were other churches such as the German Brethren, the Baptists, Methodists, Mennonites, Quakers, and French Huguenots. And these are just a few of the many types of Christians that came. Word spread fast that in America there was freedom for Christians.

America was a land of freedom. But, it was a land of Freedom for Christians. The people who lived here were expected to be Christians. They didn't make anyone take a test to see how much they knew about the Bible or anything like that. But everyone who lived here were supposed to do their best to be good Christians and to follow the 10 Commandments. The 10 commandments are not Church rules, they are God's rules - the moral rules - and these were supposed to be followed by everyone who came to live in America. America was not built for Muslims, Jews, Buddhists, wiccans, Hindus, or any other religion. It was built only for Christians. Anytime a new baby was born, the people who lived here considered it their duty to raise the little baby to be a Christian.

America was also built for white people. There were people here that were called Indians. There are many types of Indians. Some people believe that some Indians are descendants of Vikings and Hebrews that lived here hundreds and thousands of years ago. But whether that is true or not is not part of the discussion now. All the people that lived here so long ago are called Indians. When the klan says that America was made for white people, we are often called haters. You may hear your teacher or someone on television say that the white people took the land away from the Indians. Or they may say that white Christian people did not build America. America was already here for thousands of years.

We must decide what America is. Is America a piece of land with New York City on one side and Los Angeles on the other? Or is America an idea. To say that America is an idea sounds kind of strange if you have never thought about it that way. How can a piece of land be an idea?

In geography class you probably learned that America was named after Amerigo Vaspucci - a Portuguese Christian, explorer and brilliant man. He developed a system for determining exact longitude and latitude (measurements of the earth). The German publishers of a new geography book put out in 1507 credited Vaspucci with discovering the mainland and placed the word America on the map.

There have been a few other theories about where the name comes from. One is that it came from ancient people who lived here The name AMERICA or AMERRIQUE in the Mayan language means, a

country of perpetually strong wind, or the Land of the Wind, and sometimes the suffix '-ique' and '-ika' can mean not only wind or air but also a spirit that breathes, life itself. Even if this were true, in later books as we see the evidence of the white people building great civilizations in America and their worship of God we can see the similarity between God who breathed life into Adam and God who breathed life into our country.

The name as it finally was spelled America - means the kingdom (government) of God. The last part "rica" is German for government and amer is a Latin root word for God. America is God's government.

In the Bible, Zion was the capitol of Israel (remember that in later books we will prove that the white race and Israel of the Bible are the same people - don't confuse this with modern Jews - they are imposters) Zion is used as a symbol of the center of God's government. This is why the pilgrims called the new world Zion. This was a land of Christian government. The Bible says, "I will take you one of a city and two of a family and bring you to Zion" Jer. 3:14

In 1857 at the request of Congress, on the anniversary of George Washington's birthday, Rev. F.E. Pitts of Tennessee delivered some important messages to Congress. Reverend Pitts gave Congress 15 reasons why he believed that America was the new Zion of God and was the place where God said he would bring his sons and daughters from many nations together into one great land to be ruled by God's laws and who would proclaim the Christian message to the world. America was called a melting pot because it brought white people from many different countries together into one great Christian land. This is called the "regathering" time and is talked about in the Bible. We'll look at those 15 reasons in another book at another time. What we are considering now is America as an idea and not just a piece of land.

America has a unique government because it is by the people and for the people. This is the same type that Israel had in the Old Testament. America was founded to be a Christian government. A government and the laws are ideas not things. There may have been Indians living on the land, but they did not invent the ideas that America are built on. The United States of America was an idea of a Christian government for white people. Indians may have lived on the land, but they didn't own the idea or the meaning of America.

Now, we will see that they did not own the land either. Many people try to make white people feel guilty for living here. They say we stole the land and were very mean to Indians. This is a lie and here are the reasons why.

Laws Made By Whites for Whites

All of the laws of the United States were made by whites for whites. All colonial charters, patents, commissions and grants for the founding and establishing of settlements in America originated from White European nations. The Mayflower Compact, the first document of self-government in America was formed by white people. The Fundamental Orders of Connecticut, the first written constitution in America was formed by white people and government offices were only for whites. The Articles of Confederation of the united Colonies of new England which was the first union of colonies was made by white people for their descendants and was to last forever. The Declaration of Independence of 1776

was signed by white people who had been elected by whites. All of the laws of America referred to Indians as "Indian", "Native," or "Savage", and never as a citizen. Throughout the entire settlement of America, no Negro ever settled here on their own. They were always brought here as slaves. Negroes and Indians were subjects of white government and had the natural right to self defense, but were never citizens. Representatives were chosen according to the number of white citizens.

Above are listed some of the early laws, acts, and constitutions that were made by whites for whites. The main one we think of is the Constitution of the United States of America. It too, was written by white people for white people. It says, "We the people". Who were the people? They were white people. The Preamble to the Constitution says they are writing the constitution for "ourselves and our posterity." The word posterity, as used in the preamble, is a racially oriented word. It is described in Webster's Dictionary of 1828 as follows:

Posterity:

1. Descendants; children, children's children, etc. indefinitely; the race that proceeds from a progenitor. There is no way that the black, red, brown, or yellow races can be the posterity of the white race. In one of the most important legal cases in U.S. history *Dred Scott vs. Sandford*, 19 Howard 393, in 1856 it was ruled that the words "people of the United States" and "citizens" are synonymous terms and mean the same thing. They describe the political body of the country that holds the power and elects the government. Only the white race elected officers and only white Christians could hold public office. In the decision, it was pointed out that Negroes were called citizens in a couple of states, but not in all the other states. According to law in order to be a citizen of the United States you had to be a citizen of all states. Negroes were never citizens of the United States only subjects who were required to obey the law. They were also regarded as a separate class of people than whites. Whites were recognized as the organizers of the United States government and the only ones who were citizens. Negroes did not have the right to bear arms (keep guns), vote, be a witness against whites, be on a juror, hold a political office, or be in the army. Marriages between whites and blacks were against the law. They were not even allowed to live in most Northern states unless paying a large bond (money). In 1821 there was a debate over whether free blacks were citizens. The Attorney General of the United States William Wirt said, "I am of the opinion that the Constitution, by the description of "citizens of the United States," intended those only who enjoyed the full and equal privilege of white citizens."

Chancellor Kent said that Negroes are subjects but never citizens. The laws of the states, territories, and colonies allowed only whites to vote. White not all whites could vote in all elections because it was up to different states to decide the qualifications, age, etc. of the voters - only whites could be considered and were citizens. Before the states would ratify (agree) to signing the Constitution, the southern states wanted to make sure all the people living in the states were counted. The number of representatives that each state got to have in Congress was decided by how many people were living in each state. The Southern states didn't have as many white people living there as the Northern states. The southern states did have a lot of slaves though, but of course Negroes (slave or free) didn't count as citizens. The southern states were able to get the Negroes counted as 3/5 of a person - that way the southern states

could have more representatives in Congress. White men and women were counted as 100% free citizens.

America was discovered by white Christian people, it was settled and explored by white Christian people, and its laws were made by and for white Christian people. It wasn't their intention to hate non-white people or to hurt them. They wanted everyone to follow the laws of God. They knew that homosexuality and race mixing were a sin. They came from all over Europe to have a great free nation for white Christian people.

As a young white Christian, it is your duty to learn about your heritage. But, even more it is your duty to honor your heritage and the men and women who worked to make America an outstanding nation for the Lord. There are many who are working night and day to destroy what our ancestors worked so hard to build. We must remember that we can't make it better over night. And in the end, we also have to remember that God has a great plan for us. Sometimes we want things to get better sooner. God will work and train each of his Christian soldiers - not to fight a war with guns and bullets (though its always important for families to be ready for self defense) but we are fighting a war to win the hearts and minds of our people. We want them to know that we love them and that we are working for them. They have forgotten the hardship of their ancestors and are quick to believe that homosexuality and race mixing is ok. We must educate our selves first. And then when we are adults we can begin to educate others and help them to see the sin they are involved in or promoting. We must warn them that the preachers of America are lying to them and are false shepherds who are working for the one world church and the mark of the beast.

As you complete this first book of study, we hope you have learned many things about your country. Some who study this will be from a white country other than the United States. Do not feel that you have wasted your time in studying the White Christian foundation of America. America is a world leader and is responsible for setting and determining much of the policy of the world. So it is important for you to know that the country that claims to be a melting pot of non-whites and whites is not. Just like the countries of Europe, the U.S. was also founded as a white Christian country. In fact, America is gathering place for white people from all over the world. Sadly today, we are being overrun by non-white immigrants - just like your countries are being overrun.

Let us all be brave and strong. Let us remember the fight we are in for white Christian revival. Let us remember that God is truly on our side. Others may say it - but when we say it - IT IS TRUE! Keep this book and study and look it over often. This will complete your study for the 1st Degree. Congratulations on a job well done and for striving to regain the knowledge that has been taken from so many. Where there is no vision, the people shall perish.
